Foundation any portion of the amount granted, and any earnings on such amount, which is not used for the express purpose of the Grant.

Monitoring. Grantee will permit the donor to monitor the project and will, as requested, submit progress reports to the donor. If the Foundation is not satisfied with Grantee's progress toward achieving the goals of the grant, or if the Foundation determines, in its sole discretion, that Grantee is incapable of satisfactorily completing the work of the grant, the Foundation may, in its sole discretion, (i) withhold payment of grant funds until the Foundation is satisfied that its concern(s) has been addressed and the Grantee can satisfactorily complete the work, or (ii) declare the grant terminated.

Any grant payment may be discontinued, modified, or withheld at any Remedial Actions. time when, in the judgment of the Foundation, such action is necessary to comply with the requirements of law or of this Agreement. The Foundation's decision for discontinue, modify, or withhold any grant payment will be final and binding.

No Active Participation in the Project. The Foundation's participation in the project is limited to funding the Grantee and monitoring the project to determine whether the grant is being used in accordance with this Agreement. The donor is not responsible and will not be involved in the recruitment process. This is the responsibility of the Grantee.

Records. The Grantee will maintain records of receipts and expenditures of grant monies and make its books, records and personnel available to the donor at reasonable times.

Miscellaneous Provisions

No Promise of Future Funding. Grantee acknowledges that the Foundation has made no actual or implied promise of funding except for the amounts specified by this agreement.

Amendments. This Agreement can be modified upon mutual consent of both the undersigned parties as deemed necessary. The amendment may be required in case of market inflation and salary increment of teacher is required.
